Ref : Your letter NO.FMP.12/88/Pt./1, dated 22/24 April, 1989.

Sir

I am directed to say that this State Government agree to your proposal regarding the drawal of pension through the Public Sector Banks within this State by the pensioners of the Government of Assam who are residing in Meghalaya. In this connection the Scheme of this State Government contained in this Department letter NO.FEM(PC)24/87/392, dated 16.3.1988 which was partially modified vide this Department Office Memorandum NO.FEM(PC)16/87/285, dated 28th August, 1989. Copy of which was sent to you may also please be referred to.

- 2. The above benefit is hereby extended to your pensioners subject to the following conditions:-
- (i) That the scheme for payment of pension through the Public Sector Banks will continue to be inforce both in your State and in this State in which the pension is to be drawn. At present only two selected Public Sector Banks namely (1) United Bank of India and (2) Bank of Baroda have executed indemnity Bonds as provided under the scheme.
- (ii) That the facility will be provided through the above mentioned Banks which have been selected by this State Government for payment of Pension to its own pensioners residing in this State.
- (iii) That the procedure for switch over from treasury to the Bank for the purpose of payment of pension will be the same as has been prescribed in the scheme introduced by this State Government.

- (iv) That the payments, if made, will be distinctly shown by the Banks in the payment scrolls against the State Government to whom the payment is debitable. The payment will, however, be initially taken against the cash balances of the State Government in which the paying branch of the bank is situated.
- (v) That the payment made on behalf of you or State Government will be consolidated by the Accountant General, Meghalaya with reference to the payment scrolls received by him through the concerned District Treasury. The Accountant General, Meghalaya will also be responsible for obtaining re-imbursement of the amount so paid from the Accountant General, Assam.
