## Sir,

It has been noted that of late the attendance of Officers and Staff in the Secretariat and in the Offices of the Heads ofnepartments has greatly deteriorated as many of the Officers and Staff fail to come to office on time and leave office early.

All Officers and staff are expected to be in their respective seats by 10.15 A.M. at the latest.

In order to ensure that bunctuality in attendance in all Government Departments/Offices are strictly observed, it has, been Accided that in each-Secretariat Department, an Under Secretary/ Superintendent should be made responsible for timely attendance of office by the staff. Officials and Staff coming to effice after 10.30 A.M. should be categorised as late commers and one day's casual leave should be deducted for three such late attendance. The attendance register should be put up to the Secretary/Commissioner and Secretary in each Department every day immediately after 10-30 A.M. by the Under Secretary/Superintendent with remarks in red ink.

Similarly, in the Heads of Department's Offices, the-Seniormost Superintendent or an appropriate Officer should be made responsible for proper maintenance of attendance Sheet and he/she should put up the attendance sheet every day to the Head of the partment immediately-after 10.30 A.M.
