OFFICE MEMORANDUM

Sub; Counting of service for the purposes of pension of employees of the State Government and State Autonomous Bodies seeking absorption in Autonomous Bodies under the Central Government and vice-versa.

The undersigned is directed to say that question of the counting of service for the purpose of pension in the cases of (a) employees of the State Government absorbed in Central Autonomous Bodies, and (b) employees of State Autonomous Bodies absorbed in Central Government and Central Autonomous Bodies and vice-versa has been considered in consultation with the Government of India. The Governor of Meghalaya has now been pleased to decide that these cases may be regulated in accordance with the principles as laid down the Government of India, Ministry of Home Affairs, Department of Personnel and Administrative Reforms Office Memorandum No.28(10)/84-P & PW-Vol-II, dated the 7th February,1986 (copy enclosed) read with relevant orders of the Central Government as accepted by this Government vide Office Memorandum No.FEM(PC)38/87/50, dated 25th January, 1990.

2. These orders shall apply to employees of the State Government and State Autonomous Bodies moving to the Central Government and Central Autonomous Bodies and vice-versa on the basis of reciprocal arrangements on the date of issue of these orders irrespective of the date of their absorption. Similar benefits as contained in these orders may be extended to the employees of other State Government (s)/Other State Government Autonomous Bodies, as the case may be, as when such reciprocal arrangement are entered into between this Government and concerned State Government(s).
