OFFICE MEMORANDUM

Subject—Revision of mileage allowance admissible to Minister for journeys by own cars/allotted cars, etc.

The undersigned is directed to say that in view of the rise in the prices of petroleum products, the Governor of Meghalaya is pleased to order, in modification of this Department's Notification No.FEM.81/77/22, dated 15th July, 1980 that the rates of mileage allowance to the Ministers shall be as indicated below, with effect from the 13th January, 1981.

For journeys by road a Minister shall be entitled to mileage allowance at the rate given below :—

1. If Minister travels in his own car, and it run by petrol, mileage allowance shall be as follows :—

(a) Standard 10 73 p. per km.

(b) Fiat 81 p. per km.

(c) Ambassador 99 p. per km.

(d) Cars with an engine of 28 HP and above—

(i) during the first years of purchase of the car (New). Rs.1.32 p. per km.

(ii) for the next two years of purchase Rs.1.55 p. per km.

(iii) after four years of purchase ... Rs.1.78 p. per km.

(e) Jeep, Station Wagon and other vehicles like Plymouth, Desoto, etc.

(i) during the first years of purchase of vehicle (new). Rs.1 15 p. per km.

(ii) for the next two years after purchase Rs.1.25 p. per km.

(iii) after four years of purchase ... Rs.1.32 p. per km.

2. If the Minister travels in a car allotted to him by Government under the Act and it is run by petrol, mileage allowance shall be admissible at the following rates irrespective of whether a night is spent outside the headquarters or not, provided the cost of propulsion is borne by the Minister himself

(a) during the first two years of purchase of the vehicle (new) :

Standard	51 p. per km.
Fiat	59 p. per km.
Ambassador	74 p. per km.
Cars with an engine of 28 HP and above				Rs.1.21 p. per km.

(b) for the next two years after purchase—

Standard 10	58 p. per km.
