The undersigned is directed to say that consequent upon the decision of the Government on the recommendation of the Fourth Meghalaya Pay Commission at Item 7 of the Resolution, the Governor of Meghalaya is pleased to sanction Winter Allowance at the rate of Rs.400/- p.m. to all categories of State Government employees, including members of the All India Service stationed at places with an elevation of 1000 metres above mean sea level. The allowance shall be admissible for a period of four month, commencing from the month of November to the month of February.

The expenditure on account of payment of Winter Allowance shall be debited to the head of account from which the Government employees draw their salaries.

This order shall take effect from 1<sup>st</sup> November, 2009.
