Restriction of expenditure under Non-Plan during 2011-2012. Subject:

Sir,

I am directed to say that due to emerging budgetary deficit and resource constraints during the current financial year (2011-2012), it has become imperative to curtail avoidable and unproductive expenditure. With a view to achieve this objective, it has been decided to immediately restrict the incurring of all Non-Plan expenditures except the following :-

- 1. Salaries (including withdrawals from GP Fund) and Wages
- 2. Travel Expenses
- 3. Others i.e. POL/Office Stationery/Rents, Rates and Taxes/Telephone /Electricity / Ration & Clothing for Police Personnel/Stipend/Scholarship/Medical Treatment/Pension and Retirement Benefit/Honorarium to Chairmen vice-Chairmen etc/Diet Bills for Hospitals/ Prisons/ Animal Feed/Time bound decretal amounts.
- 4. Repayment of Principal and payment of interest to Central Government and Financial Institutions.

Departments are advised not to incur liabilities in anticipation of carrying over actual payment to the next financial year. No expenditure should be incurred through reappropriation except for the above 4 items.

The contents of this order may kindly be brought to the notice of all officers under your control with instructions that demands for LOA/LOC for the 4<sup>th</sup> quarter should invariably indicate specific items of expenditure under the above heads particularly under item (3) above to avoid delay in issue of LOA/ LOC.
