PRESS RELEASE

Based on credible intelligence input, the Anti-Narcotics Task Force of East Jaintia Hills District Police conducted a coordinated Naka operation under the jurisdiction of Lumshnong PS in the early hours of 19th August 2025. **During the operation, the team successfully apprehended two (2) persons who are part of inter-state gang and recovered 10.35 KGs of Marijuana, 2,736 Tramadol Hydrocholoride capsules, 6000 Nitrazapem tablets and 2 mobile phones from their possession. These apprehended drug suppliers are suspected to be part of larger Organised crime syndicate.**

On the night of 18th August 2025, East Jaintia Hills District police received credible information about suspected persons travelling from Silchar, Assam to Shillong clandestinely in MTC Night bus, suspected to be carrying illegal narcotics. Acting promptly on this input, a team led by Lumshnong Police Station set up naka and, at approximately 04:00 AM on 19th August 2025, the team intercepted a MTC bus B/R no ML-03-0222 and apprehended the following persons: 1. Shri Amol Nath (42 years) s/o – Shri Suresh Nath, r/o – village – Sundari Part -III, Silchar, Kachar, Assam and 2. Shri Radika Ranjan Das s/o –(L) Ranjit Das, r/o – village – Bamonchora, PS – Komalpur, District – Dholai, Tripura.

In the presence of independent witnesses, a search was conducted under Section 50 of the NDPS Act, during which a 10.35 KGs of Marijuana, 2,736 Tramadol Hydrocholoride capsules, 6000 Nitrazapem tablets and 2 mobile phones were recovered from their possession. Accordingly, a case has been registered at Lumshnong Police Station under the NDPS Act, and investigation is underway to establish backward and forward linkages.





If any person has any information about other miscreants involved in this illegal act, they are requested to inform the local Police Station immediately. Their identity shall be kept secret and suitable reward shall be given.
