**No.Health.232/2015/27** :- In exercise of the power conferred under section 21 of the Meghalaya Nursing Council Act, 1992 Governor of Meghalaya is pleased to amend the Meghalaya Nursing Council Rules, 2021 as follows, namely:-

1. Short title and commencement, - (1) These rules shall be called the Meghalaya Nursing Council (Amendment) Rules, 2022.  
(2) It shall come into force from the date of its publication in the official Gazette.
2. Amendment of Rule 3, - (1) After the existing clause (d) of sub-section (1) of Section 3, a new clause (d1) shall be inserted as follows,  
“(d1) The Joint Director of Nursing, Meghalaya, Shillong.”  
(2) In the existing clause (e) of sub-section (1) of Section (3) the words “O/o the Director of Health Services (MI),” shall be omitted.
