## **NOTIFICATION**

## No. ERTS(S)5/2019/Pt/79,

## Dated Shillong, the 23<sup>rd</sup> August 2022

In exercise of the powers conferred by Section 75 of the Indian Stamp Act, 1899 (Central Act No. 2 of 1899, the Governor of Meghalaya hereby makes the following rules further to amend the Meghalaya Stamps Payment of Duty by means of E-Stamping) Rules, 2020, namely:-

- 1. <u>Short title and Commencement</u>:-(1) These Rules may be called the Meghalaya Stamps (Payment of Duty by means of E-stamping) (Amendment) Rules, 2022.
  - (2) They shall come into force with effect from the date of notification in the Official Gazette.
- 2. <u>Amendment of Rule 20</u>:- In the Meghalaya Stamps (Payment of Duty by means of E-Stamping) Rules, 2020, (hereinafter referred to as principal Rules), in rule 20

(a) after the words "payment of Stamp duty amount" the following words shall be inserted. namely:-

"and the requisite service fee may be prescribed by the Government by way of notification."

(b) after the words "e-Stamp Certificate" a full stop shall be substituted by a colon and the following proviso shall be inserted, namely:-

"Provided that any person may directly login to the designated portal of the CRA and directly pay the amount of e-stamp Certificate not exceeding ₹500/- (Rupees five hundred) only in denomination, after first registering in the system, and the CRA shall **after prompting the purchaser to verify the correctness of the entries in FORM-4**, provide a downloading facility for the e-stamp Certificate:

Provided further that the Government shall by notification appoint the date for implementation of the provision contained in the first proviso".

3. <u>Amendment of Rule 22</u> :- In the rule 22 of the principal Rules, in sub rule (1), for the existing clause (iii) the following shall be substituted, namely:-

"(iii) download the e-stamp Certificate vide Annexure-A1, take out its print, signed with the date and affix his official seal on the print out:

Provided that the e-Stamp Certificate downloaded by a person under the proviso to rule 20, shall be signed by the authorised official of the Approved Intermediary using Digital Signatures Certificate of class III and above: and"

4. <u>Amendment of Rule 25</u>:- In rule 25 of the principal Rules, after the words "amount of additional Stamp duty" the following words shall be inserted; namely:-

"and the requisite service fee as may be prescribed by the Government by way of notification"
